IV. CHAIRPERSON'S REPORT

USS Operation Budget Summary

- Presented an overview of the USS operational budget 2024 expenses. Outlined the audit of 2023 expenses and included the expenses in the 2024 budget. Described the process of receiving accurate data based on projected enrollment and collections. Outlined the four budget lines of the USS and the surplus budget line. Reviewed historic and traditional accounting customs of the body. Acknowledge if the students are receiving services based on the fees being paid. Transparency and fiscal accountability was emphasized.

USS Scholarship

-Presented an update on the completed processing and disbursement of all scholarships rewards. Described timeline of upcoming scholarship process. Plans for a new USS scholarship were outlined, focusing on addressing previous administrative challenges. A meeting was held with Suaya, responsible for the scholarship portal, to streamline the application process. The application process and timeline was reviewed. The scholarship committee debated potential start and end dates for the new scholarship, emphasizing the need to set these dates well in advance to ensure proper preparation and implementation. A significant emphasis was placed on the need for more volunteers to help with the scholarship review process to avoid delays similar to those experienced in previous years.

Legislative Updates

- Outlined the upcoming Cuny on the Hill trip, a traditional USS and CUNY collaboration. 32 students traveling to Washington DC for a day trip to advocate for students. Includes a tour of Capitol Hill, lobbying for CUNY earmarked funds, a fellowship fair and a reception.
- Presented an update on the CUNY Free Unlimited Metrocards Proposal. A new initiative was proposed to provide free Metro cards to students, aiming to facilitate easier transportation across the city which could aid in increasing student engagement and attendance. Develop a detailed proposal for the Metro card initiative, including eligibility criteria and implementation strategies.
