# The State of New York OFFICE OF THE ATTORNEY GENERAL CITATION

Whereas, it is a longstanding tradition of the Office of the New York State Attorney General to recognize those organizations that strengthen our communities, support young people, and consistently endeavor to improve the well-being of New Yorkers; and

Whereas, establish in 1972, the University Student Senate (USS) of the City University of New York (CUNY) has played a vital role in representing the aspirations and interests of CUNY students; and

Whereas, by preserving the accessibility, affordability, and excellence of higher education within CUNY; USS is protecting the rights of the student body and promoting the general welfare of its students as well as the University as a whole; and

Whereas, today, the USS delegates are responsible to the representative governance of 500,000 students across the twenty-five CUNY campuses; now therefore be it Resolved, that on this, the fifteenth day of October, to the year Two Thousand and Twenty-three, the Office of the New York State Attorney General deems it right and fitting to congratulate the University Student Sensate of the City University of New York,

on its 50<sup>th</sup> Anniversary and commends its leaders and members for thir on-going commitment to enhancing the ducational experience, advocating for student rights, and fostering a sense of community within the institution.
